1. INTRODUCTION

1.1 You will be able to access most areas of this Website without registering your details with us. Certain areas of this Website may only be open to you if you register.

1.2 We may revise these terms and conditions at any time by updating this posting. 2. ORDERING FROM US

2.1 We do not currently have an online ordering facility on this website, but you may send your requests via our contact page and we will contact you to confirm your requirements and pricing where necessary.

2.2 Our acceptance of an order takes place when we despatch the order. When we despatch the order the purchase contract will be made even if your payment has been processed immediately, unless we have notified you that we do not accept your order or you have cancelled your order.

- 2.3 We may refuse to accept an order:
- (a) where goods are not available;
 - (b) where we cannot obtain authorisation for your payment;
 - (c) if there has been a pricing or product description error; or
 - (d) if you do not meet any eligibility criteria set out in our terms and conditions.

3. PRICING

- 3.1 All prices quoted exclude VAT. Where applicable, this will be shown separately and added to the invoice total at the current rates.
- 3.2 Where we charge separately for packing, carriage and insurance and other relevant charges, you will be notified prior to us accepting your order.
- 3.3 Our prices are reviewed periodically and the next review will be on 01/06/2009.

4. CANCELLATION AND RETURNS POLICY

- 4.1 If you wish to cancel your order:
- (a) you can notify us by email to info@norfolkwater.co.uk before we have dispatched the goods to you; or
 - (b) where goods have already been dispatched to you, by returning goods to us in accordance with clause 4.2 below.
- 4.2 You can return goods you have ordered from us for any reason at any time within 14 days of receipt for a full refund or exchange. The costs of returning goods to us shall be borne by you.
- 4.3 Upon receipt of the goods we will give you a full refund of the amount paid or an exchange credit as required.
- 4.4 The rights to return the goods to us as referred to in clause 4.3 will not apply in the following circumstances: -
- in the event that the product has been used
 - to any products that by their nature cannot be re-sold such as bottled water
 - where goods are taken on a signed rental contract, the terms of that contract will take precedence

The provisions of this clause 4.4 do not affect your statutory rights.
